## DOG BOARDING CONTRACT

NOTE: We are \*NOT\* veterinarians, and do not do injections. Oral or topical meds can be administered if they are provided to us with clear written instructions. Pet parent specifically agrees that *Die Hundemutter* will not be held responsible for any medication errors or issues.

- 1. Owner agrees to pay the rate for boarding ( 25 €/day/dog ) upon pet`s pick up (cash only). Guests are charged for their date of arrival, regardless of what time they check in. Check-out time is 12 a.m. Guests who depart after 12 a.m. will be charged for the departure day. Owner further agrees to pay all costs and charges for special services requested and for all veterinary and transportation costs for the during the time said pet is in the care of *Die Hundemutter*.
- 2. Pet's food must be provided in sufficient quantities by Owner.
- 3. Owner understands and explicitly agrees to be solely responsible for any and all acts of behavior of its pet occurring during the term and time of this agreement and specifically waives and agrees to release *Die Hundemutter* from any liability with respect to its pet of any kind, character, or nature whatsoever, arising out of or from boarding this pet or any and all damages which may accrue from any other cause whatsoever including loss by fire, theft, running away, death, injury to persons, animals or property, or death or injury to any other animal cased by the within named pet during the term of this Agreement, whether this pet be on the premises of *Die Hundemutter* or not.
- 4. Owner represents that she/he is the sole owner of the listed pet in this agreement and that no lien or mortgage against its pet exists.
- 5. Owner specifically represents that its pet has not previously shown signs of aggression towards other animals or people and further agrees to be fully responsible and liable for all acts or behavior or mortgage against its pet exists.
- 6. Owner does hereby entrust *Die Hundemutter* to care for said pet and authorizes *Die Hundemutter*, in its sole discretion, to perform whatever is necessary for the health and well-being of the Owner's pet. Owner further explicitly authorizes *Die Hundemutter* to take its pet to a veterinarian of *Die Hundemutters* choice and agrees to pay for any and all expenses relating to the pet's care, transportation, and board. Owner agrees to hold *Die Hundemutter* harmless for any illness, accident or injury and specifically agrees to be solely responsible for any and all damages that pet may cause to *Die Hundemutter* and to *Die Hundemutter's* attendants, other animals, guests.
- 7. The Owner is fully liable for any damage that occurs in or to he house and its premises (e.g. furniture)
- 8. *Die Hundemutter* is not responsible for any damages of the pet's items provided by the Owner such as leashes, beds etc.
- 9. Owner acknowledges that despite *Die Hundemutter's* best effort to avoid accidents and illness, that such accidents and illnesses sometimes occur. In the event of a life-threatening situation, and Die Hundemutter cannot communicate with Owner, Owner directs that *Die Hundemutter* shall **(choose just one of the following)**: Initial: \_\_\_\_\_ Engage in all possible measures to save the pet/animal(s) Initial: \_\_\_\_\_ Defer to the veterinarian's recommendation.
- 10. In the event of undesirable pet behaviors, which include, but not limited to the following: signs of aggression and destructive behaviors, etc., Owner agrees that *Die Hundemutter* may separate the pet. If this action does not solve the problem, *Die Hundemutter* will notify Owner by telephone, text or e-mail and Owner agrees to promptly remove pet from *Die Hundemutter's* premises. "Undesirable behaviors" shall be defined solely by *Die Hundemutter*.
- 11. If a pet is not collected within 14 days after the date on which it was originally due to leave *Die Hundemutter*, and the final account has not been settled in full, *Die Hundemutter* is authorized to sell or otherwise dispose oft the animal at own discretion.
- 12. Please read carefully before **choosing one of the two options** below, as this limits our liability. We are asking all pet parents to carefully assess the exterior fencing and evaluate it for its ability to contain his or her animals.
- O I have personally inspected facility's exterior fencing (play yards) and assert that it is adequate to contain my pets safely. I hereby authorize *Die Hundemutter* to allow my pet to play freely in the play yards and release the facility from any and all liability in the event that my pet jumps or climbs over any fencing or enclosures. Additionally, I agree to pay for any damage or injury to property, people or other animals that results from my pet escaping.

O I have inspected facility's exterior fencing and am NOT confident that it is adequate to safely contain my pet. I do NOT authorize <i>Die Hundemutter</i> to allow my pet to play in the play yards, but request that it may be taken outside on a leash only. In the event that my pet does jump or climb over any fencing or enclosure, I hereby release the facility from any and all liability and agree to pay for any resulting damages or injury to other animals, people or property
