Prices per dog

Overnight stay::

A rate of **30.00 EUR per day** including overnight stay is charged. The drop off day is billed in full. The pick up day is only billed with **20.00 EUR** if the dog is picked up after 12:00 PM.

From the 21th day onwards, a 5% discount is granted on the total bill (excluding extra costs).

Dayboarding:

A rate of **20.00 EUR** per day is charged for stays between 08:00 AM and 06:00 PM (Sundays between 10:00 AM and 06:00 PM).

Note: Bookings made before 01.01.2026 are excluded from the price increase, but not from the updated Terms and Conditions (as of 01.01.2026).

Full payment of all costs must be made **in cash** upon collection of the animal.

Cancellation fees:

In the event of a short-term cancellation (less than eight days before the arrival date), 50% of the total booking price will be charged.

In the case of early pick up, the full total price calculated up to the agreed collection date remains due.

Extra fees:

The dog must be house-trained. In the event of repeated soiling (urine/feces, documented via video evidence) or the onset of heat, we reserve the right to charge an additional fee of 2.00 EUR/day.

General Terms and Conditions

1. Contractual binding:

This contract is consistently binding for ALL stays of the animal(s) named on page 1 from the date of signature and only needs to be completed once.

2. Authorization & Consent

The PO had the opportunity to inspect the premises, fencing, facilities, and transport vehicle prior to signing. The PO agrees to the nature and condition of the facility. The PO consents to the dog being walked or taken to the vet on a leash outside the property.

3. Housing & Liability

The PO is aware that dogs are kept in unleashed group housing within the home, not in individual kennels. The PO accepts the risks of dog fights and agrees to bear any resulting veterinary costs for their own dog and, if their dog is at fault, for the bitten dogs.

The DBF reserves the right to demand immediate collection of the dog (at full cost) in cases of aggression, incompatibility, persistent barking, or inability to be alone or to settle down.

The PO confirms the dog is socially compatible and poses no danger to humans.

The PO is fully liable for any damage caused by the dog to the premises, equipment, persons or any other damage. A valid pet liability insurance must exist.

4. Liability of the DBF

The DBF is only liable for damage, loss, or death of the animals if caused by intent or gross negligence by the DBF or its representatives.

No liability is accepted for brought items (blankets, toys, etc.) or for cancellations by the DBF due to illness.

5. Health status

The PO confirms that the dog is dewormed, free of parasites/contagious diseases, and clean. If treatment by the DBF becomes necessary, it is at the PO's expense. If a dog introduces a contagious disease, the PO bears the costs for disinfection and treatment of other affected dogs.

6. Vaccinations

The PO confirms that the dog has valid vaccinations against Hepatitis, Parvovirus, Leptospirosis, Distemper, Kennel Cough, and Rabies. The vaccination record must be left with the DBF.

Sick or parasite-infested dogs will be rejected; in such cases, the full price is still due immediately in cash.

7. Veterinary care

The PO agrees that in cases of emergency, acute illness, or injury to the dog, necessary treatment shall be administered by a veterinarian chosen by the DBF. In such cases, the DBF is expressly authorized to commission a veterinary practice for the medical care and treatment of the animal in the name of and for the account of the PO. The PO shall bear all costs. The invoice must be paid in full and in cash on the day the animal is picked up. The DBF will attempt to contact the PO or their authorized representative prior to any veterinary visit. If the DBF is unable to reach anyone, it shall be at its discretion to decide on the treatment of the animal and—in the worst-case scenario and only upon the express recommendation of the veterinarian—on the humane euthanasia of the dog.

8. Neutering and Heat

The PO confirms that their male dog is neutered or that their female dog is not in heat. Female dogs in heat will not be accepted. In such cases, the DBF reserves the right to withdraw from the contract. Unneutered (intact) male dogs will not be accepted.

9. Taxes & Identification (Not US Military)

The PO confirms that their dog is officially registered for dog tax. If, during the dog's stay at the boarding kennel, the animal is found to have insufficient identification during an inspection by the public order office (*Ordnungsamt*) or the police, the PO shall bear any resulting costs.

10. Grooming / Care

The DBF is under no obligation to clean dogs that have become dirty during their stay.

11. Extensions & Delays

In the event that the dog is not picked up at the agreed time, or if the duration of the stay is extended by mutual agreement, the additional days will be invoiced to the pet owner at the current rate.

12. Additional Costs

Any additional costs not listed under "Prices" that may arise (e.g., veterinary fees, medication, food, etc.) must be paid in cash upon collection of the dog.

13. Photos and Videos

The DBF is permitted to use film and photographic recordings of the animal for its own promotional and marketing purposes.

14. Duty to Cooperate

The PO confirms that all information provided is complete and truthful. The PO undertakes to immediately notify the DBF of any changes relevant to the boarding that occur after the contract has been concluded. Furthermore, the PO agrees to inform the kennel of the expected arrival time at least 48 hours prior to the animal's arrival on the drop-off day.

15. Data Protection

The PO consents to the use and processing of the personal data provided, insofar as this is necessary for the performance and administration of the contract.

16. Severability Clause

Should one or more provisions of this contract be or become invalid, this shall not affect the validity of the contract as a whole. The invalid provision shall be replaced by the statutory regulations in effect at the time the contract was concluded. No oral agreements have been made; only those fixed in writing shall form an integral part of this contract.
